PROJECT UPDATE

PROPERTY TAX BURDEN IN BOISE

The property tax analysis for the City of Boise is due on Friday, December 13th. The research team received feedback from the City on the initial data analysis sent early November. The team is currently working on incorporating the feedback into the report. It is also conducting case studies based on additional data provided by the City and the County Assessor's Office. The initial data analysis and the case studies will be integrated into the final report.

STATE BOARD OF EDUCATION

The State Board of Education evaluations for Early Literacy, Advanced Opportunities and College and Career Advising and Mentoring programs are underway. IPI has received all of the quantitative data and has completed collecting the qualitative data (via a survey instrument and elite interviews). Data analysis and report drafting will be completed this month. The evaluations will be presented to the State Legislature in January 2020.

TREASURE VALLEY SURVEY

The Fourth Annual Treasure Valley Survey was conducted September 14th – 22nd, 2019, and surveyed 1,000 adults over the age of 18 who currently live in Ada, Canyon, Boise, Gem, and Owyhee counties. Key findings include that the two growth related issues that people are the most concerned with are traffic congestion and affordable housing, which are the same top-two that were reported in 2018. Greg presented the Treasure Valley Survey to the Treasure Valley Partnership, a group of all the mayors and county commissioners in the Treasure Valley. IDAHO'S TRANSPORTATION INFRASTRUCTURE

IPI has met with and informally interviewed all 12 supporters of the Transportation Infrastructure Project. Preliminary results from those discussions and an overall project progress update was presented to the supporters on November 14th. The team also created a video for Association of Idaho Cities to utilize to update their members at upcoming newly elected official luncheons across the state. Extensive progress has been made toward developing a funding flowchart for transportation infrastructure revenue and expenditures at the state and local level.

MONTH IN REVIEW

GOVERNOR'S TASK FORCE PRESENTATION

On November 8, 2019, Dr. Vanessa Fry, Research Director at the Idaho Policy Institute, and Guido Giuntini, a lecturer in the College of Business and Economics, presented to The Governor's Task Force on Children At Risk (CARTF). They presented results from a study examining the long term outcomes of children in Idaho's foster care system. They specifically asked the question, "Do children who have aged out of Idaho's Fourth Judicial District's Court Appointed Special Advocate (CASA) program engage with the Idaho Department of Corrections (IDOC) at the same rate as the general population?".

The study found:

- Former foster children and youth in the study are 2.2 times more likely to have interacted with IDOC than the general population.
- The ratio for males is 2.2 times that of the general population and for females it is 2.6 times.
- As former foster youths age, incidents increase.
